A. HOW TO ENTER

To be eligible to enter, Eligible Entrants must register to undertake the Power Down Pledge by visiting www.westernpower.com.au/powerdown and following the prompts to the competition entry page, inputting the requested details including their Name, Phone, Email, Business Section, BBQ pitch (In 150 words or less describe why you think it is important that the community Powers Down this summer) and submitting the fully completed entry form by 5pm, 8 March 2010.

The Power Down Pledge encourages individuals to take the pledge to reduce their energy use this summer. Individuals agree to read the tips and agree to implement as many as they can, including setting their air conditioner to 24C.
