Intent

This reference tariff change forecast has been prepared by Western Power to comply with section 8.16 of the Electricity Networks Access Code (2004) (Access Code), which requires Western Power to publish on its website the following documentation within 5 business days of the ERA publishing an approved price list under the Access Code:

- Its current tariff structure statement;
- Its current reference tariff change forecast (this document); and
- Its current approved price list.

The ERA approved 2024-25 price list was published on the [ERA website](#) on 14 May 2024.

Reference Tariff Change Forecast

The table below sets out the forecast weighted average price changes for each reference tariff provided by Western Power over AA5. The weighted average price changes included in the table reflect:

- The 2024-25 price list approved by the ERA on 14 May 2024¹, which required Western Power to:
 - Reduce the proposed connection charge for distribution connected generators by \$0.2 million to address an issue that was identified after the FY24 price list was approved by the ERA on 17 May 2023; and
 - Amend the proposed prices for the overnight charging window for the residential and business multi part time of use energy services (RT21 and RT22) such that it is not higher than the off-peak charging window; and
- Western Power’s expectation of the expected price changes for the remaining years of AA5 based on the smoothed target revenue approved by the ERA in the Final Decision and the cost allocation methodology outlined in the approved tariff structure statement.²

The weighted average price change has been calculated by holding volumes (e.g., connection numbers, energy consumption and maximum demand) constant for the relevant pricing year and calculating the percentage difference between revenue based on proposed prices for the relevant pricing year and prices for the previous year.
